Workgroup Session I (continued) Time for Change - Action (changing mascot)

- It's a racial slur
 - Pewewardy (2000a, 2000b) Mascots/branding are a form of **dysconsious racism** which erodes American Indian culture and identity in youth.
- Will still be pride in being a <u>student</u> of high school
- 2 largest Native American organizations came out against (National Indian Education Association and National Congress of American Indians)

- Unintended racial slur
- Barrier for some
